Agenda Point 1: Confirmation of the minutes of meeting held on Thursday 24th Sept 2020

Minutes of the meeting were read out by Prof. Atul Bhagwat. The same were confirmed and approved by the members.

Agenda Point 2: Review of Report of Academic and Administrative Audit of the college

Academic summary report of the academic and administrative Audit Conducted by SPP University for academic year 2021-2022 was reviewed and it was decided with consensus that work for suggested improvements shall be taken up.

Agenda Point 3: Taking overview of NAAC preparation of the college.

Prof. A.A. Bhagwat informed that NAAC accreditation is the necessity as a compliance of the DTE directives for which effort are required to be made. It was agreed with consensus that Registration of the College for NAAC evaluation is a logical next step to be taken immediately.

Registration fee and NAAC procedure fee structure was tabled in the meeting for discussion. Hon. Secretary B.K.P.S Shri Pushkaraj B Pathak suggested that, the government gives aid to the college for the students can get education at a low cost. As the institution has no other source of income as it runs an aided College, In order to develop the College, the Government has to pay rent for the premises of the institution where the Colleges are run. That Building rent has not been paid by the Government to the institution for many years. If the government pays the Building Rent to the institution, the institution will be able to develop the College. For that the Government should immediately pay the building rent to the institution. Appropriate follow-up should be done immediately for this. That means development can be done from the perspective of student interest.

In the meeting, everyone agreed that the issue raised by the honorable secretary is important and it was decided to follow up accordingly. The amount receivable from DTE grant can be utilized for this purpose. He also suggested, carrying out the necessary procedure to get sanction for additional development fund so that further development of the college in the interest of the students can be taken up.

The Meeting ended with vote of thanks to the Chair.
